 - 2. Kitchen Overage Tabitha brought up the kitchen overage. You cannot have more than 3 months of operating costs in the budget. Tabitha was creative and put together a list of potential purchases that the state approved to take care of the \$72,422 overage. One of the items was to purchase a 14 Passenger van. This would be used to deliver lunches during the summer food program. Also, the garden coordinator would be able to use the van to purchase items for the garden as well as take students on field trips during their garden class time.

We also used the money to refinish the gym floor as that is our cafeteria. We do have some services planned as well for the walk in.

School Safety - Tabitha also just purchased 20 radios that Shawn is in the process of having programmed. Kathy, Shawn, Tabitha and staff will have radios

Tabitha mentioned that the senior citizens will be coming for a Christmas lunch next week and for a private show of the Christmas concert.
